**WHEREAS**, renewal of contract of lease was necessarily to avoid delay in the delivery of basic services;


**NOW THEREFORE BE IT,**


**RESOLVED**, further that the copies of this Resolution be furnished all concerned for their information and appropriate action.

**ENACTED**, this 28<sup>th</sup> day of October 1999 at the Session Hall of the Municipal Building, Taytay, Rizal.


