WHEREAS, the said land was traversed by the construction of Coastal Road;


WHEREAS, considering that the intention to buy 4,020 sq. m. of land from Linkage Real Estate and Management Development Corporation is for the interest of public service;


RESOLVED, FURTHER, that copy of this Resolution be furnished all concerned for their information and appropriate action.
