
WHEREAS, the DEED OF DONATION is found to be in order and would be for the benefit and welfare to the people of Taytay;


RESOLVED, FURTHER, that the copies of this Resolution be transmitted to all concerned for appropriate action;

ENACTED, this 9th day of March, 2000 at the Session Hall Municipal Building, Taytay, Rizal.


