WHEREAS, the Barangay meet sustainable deliver, unblemished discharge of duties adhering the fire protection scheme of this Municipality;


WHEREAS, to confirm the sole ownership of Barangay Muzon to the mini-fire truck was resolved;

RESOLVED FURTHER, that copies of this Resolution be furnished all concerned for their information and appropriate action.




