WHEREAS, the National Health Insurance Act of 1995, in recognition of the need to provide all citizens with the mechanism to gain financial access to health service, created the National Health Insurance Program (NHIP) to serve as the means to help the people pay for the same;

WHEREAS, consisted with the vision and objectives of the National Health Insurance Program, the parties herein acknowledge their joints responsibility to provide a basic package of needed personal health services to the underprivileged and indigent segment of herein local government unit's population through the implementation of the Indigent Component of NHIP, also referred to herein as the Program, as mandated by law;

WHEREAS, a dynamic partnership forged between the national government, through the Corporation, and the local government unit's herein


represented is crucial in pursuing the principles and policies of the NHIP, particularly in the determination of households and individuals who may be entitled to the benefits of the Program;


RESOLVED FUTRHER, that the copies of this Resolution be transmitted to all concerned for appropriate action.
