RESOLUTION NO. 102

A RESOLUTION APPROVING IN REVIEW SUPPLEMENTAL BUDGET NO.02 SERIES OF 2000 UNDER APPROPRIATION ORDINANCE NO. AC-02 SERIES OF 2000 OF BARANGAY MUZON TAYTAY, RIZAL

WHEREAS, Supplemental Budget No.02 series of 2000 under Appropriation Ordinance No.AC-02 series of 2000 of Barangay Muzon Taytay, Rizal was submitted to the August Body for review;

WHEREAS, on August 15,2000 Mr. David Atanacio, Jr. Municipal Budget Officer submitted to this August Body for recommendation the approval of the same to wit;

" XXX.....
Review, Findings and evaluation are as follows:

1. Unprogramed Funds (First Quarter Release) being a part of Internal Revenue Allotment is subject to 20% Development Fund, however Installation of Artesian Well may be considered a development project so requirement of the law has been satisfied.
2. The abovementioned Appropriation Ordinance did not indicate the kind of Capital Outlay that was appropriated for P 15,000.00. Government Accounting & Auditing Manual Secs 373-379 classified Capital Outlay into Investment, Loans, Livestock & Crops, Land & Land Improvement, Building & Structures, Furniture Equipment and Books and Work Animals.

After an evaluation of the said budget, I recommend for its approval by the Honorable Body pursuant to RA 7160, subject to the following conditions:

a.) The abovementioned Appropriation Ordinance should be amended by an ordinance to classify the Capital Outlay to conform with the Government Accounting and Auditing Manual.

b.) Other Services shall be used on expenditures which are not classified under other accounts but are still considered allowable expenditures.

c.) Disbursements of the herein approved appropriation should be in a accordance with COA Rules and Rregulations.

d.) Disbursement should be within the case limit of the Barangay.


e.) That expenditures therein should be within the purpose for which they have been appropriated.....xxxxxxx”.

WHEREAS, the approval of the above cited Supplemental Budget is subject to the terms and recommendations of Municipal Budget Officer in his letter of recommendation dated August 15, 2000.

NOW THEREFORE, be it resolved as it hereby resolved. the Sangguniang Bayan Taytay, Rizal in session duly assembled hereby approves the Supplemental Budget No.02 series of 2000 with total appropriation of THREE HUNDRED TWELVE THOUSAND SEVEN FIVE PESOS (P 312,705.00) under Appropriation Ordinance No. AC-02 series of 2000 of Barangay, Muzon, Taytay, Rizal.

RESOLVED FURTHER, that copies of this resolution be furnished all concerned for their information and appropriate action.
