**A RESOLUTION REQUESTING FOR THE OPENING/
OPERATION OF THE TAYTAY NATIONAL HIGH
SCHOOL MANGGAHAN FLOODWAY EXTENSION,
LOCATED AT EAST MANGGAHAN FLOODWAY, BRGY.
SAN JUAN, TAYTAY, RIZAL.**

WHEREAS, that this school year 2000-2001, has an enrollment of 1,048 students from Manggahan Floodway, Taytay side alone;

WHEREAS, that as per interview and meeting with parents, it was found out that they P5.8 Million annually for the transportation fare alone:

WHEREAS, that the problem on tardiness and absenteeism of students will be solved with the opening of new extension school;

WHEREAS, that the traffic in this very busy part of Taytay will be decongested;

WHEREAS, that the National Authority (NHA) and the Department of Public Works and Highway (DPWH) was granted the Taytay National High School a portion of land with an area of ELEVEN THOUSAND AND

NINETY SEVEN (11,097) SQUARE METERS with TCT # 557287, located at East Manggahan Floodway, Brgy. San Juan, Taytay, Rizal respectively;

WHEREAS, that through the consultation with CONG. GILBERTO M. DUAUIT, Chairman on Appropriation to Congress, that as per funding and physical facilities will not be a problem, because he set an innovation which is the Department of Public Works and Highways (DPWH), National Housing Authority (NHA) Manggahan Floodway School Development Program;

NOW THEREFORE, RESOLVED, as it is hereby resolved, that the Sangguniang Bayan of Taytay, Rizal duly assembled in a session, is hereby granting the request opening/operation of Taytay National High School Manggahan Floodway Extension, in East Manggahan Floodway, Brgy. San Juan, Taytay, Rizal;
