WHEREAS, section 5, Chapter I of the Magna Carta for PWDs states that no PWD shall be denied access to opportunity for suitable employment;

WHEREAS, the state also recognize the role of the private sector in promoting the welfare of PWDs, and encourages partnership in programs that address their needs and concerns;

WHEREAS, the PWDs are part of the Philippine society, thus the state shall give full support to the improvement of the total well being of PWDs and their integration into the mainstream of our society;

WHEREAS, the state shall exert all efforts to remove all barriers that are prejudicial to the PWDs;


RESOLVED FURTHER, that copies of this Resolution be furnished all concerned for their information and appropriate action.

ENACTED, this 30th day of July, 2001 at the Session Hall Municipal Building, Taytay, Rizal.


