**RESOLUTION NO. 53**

**A RESOLUTION REQUESTING FOR THE INTERVENTION  
OF HER EXCELLENCY GLORIA MACAPAGAL ARROYO,  
PRESIDENT, REPUBLIC OF THE PHILIPPINES FOR  
THE SUSPENSION OF THE CONSTRUCTION/  
IMPLEMENTATION OF THE DEPARTMENT OF  
PUBLIC WORKS AND HIGHWAYS, LAKE SHORE  
DIKE PROJECT AT THE MUNICIPALITY OF TAYTAY,  
PROVINCE OF RIZAL.**

WHEREAS, the Municipal Government of Taytay, Rizal has a responsibility to promote the general welfare by preserving the comfort and convenience of their inhabitants;

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991 specifically provides; that

Chapter 3 – Intergovernmental Relation

Sec. 25. National Supervision over Local Government Units

Its National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects.

Sec. 27. Prior Consultations Required

No project or program shall be implemented by government authorities unless the consultations mentioned in Sec. 2 ( c ) and 26 hereof are complied with, and the prior approval of the Sangguniang concerned is obtained; Provided, That occupants in areas where such projects are to be implemented shall not be evicted unless appropriate relocation sites have been provided, in accordance with the provisions of the Constitution.

WHEREAS, the Municipality of Taytay, Rizal will be traversed by the implementation of the project, causing serious environmental (flood and higher water levels in surrounding area) and social (displacement of thousand of families) problems;



WHEREAS, the Project Study conducted during the period March 1991 to Dec. 1993 failed to consider various issues and concerns, such as prior consultation with different sector of the community and the resulting flood problems in the Municipality of Taytay and others, which must be properly addressed;

WHEREAS, the DPWH Project will defeat the purpose and implementation of Proclamation No. 458 (NHA- Manggahan Socialized Housing Project) and Proclamation No. 704 (Lupang Arenda as resettlement site), two (2) projects for the benefit of the urban poor of the Municipality of Taytay;

WHEREAS, the Municipal Government of Taytay, Rizal has a responsibility to look after the welfare of its constituents who will be adversely affected by the construction of the project;

WHEREAS, the Municipal Government of Taytay, Rizal, believes that further studies must be undertaken, considering various issues and concerns, before the final implementation of the project;

NOW THEREFORE, RESOLVED AS IT IS HEREBY RESOLVED, that the Sangguniang Bayan in a session duly assembled, hereby request Her Excellency GLORIA MACAPAGAL ARROYO, President, Republic of the Philippines to suspend the implementation/construction of the Department of




