WHEREAS, Electrification Project for Lupang Arenda is necessary to improve the plight of the underprivileged sector;


WHEREAS, the Municipal Government of Taytay, lacks the financial capability to implement such project;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
