WHEREAS, R.A. 7160, otherwise known as the Local Government Code of 1991, delegated specific function and responsibilities to Local Government Units (LGUs) particularly on the effective and efficient delivery of basic services and facilities at local level;

WHEREAS, there is an urgent need to provide fund assistance to LGU's in order to alleviate their financial burdens in carrying out the devolved function and responsibilities, as specified by the Code;

WHEREAS, Executive Order No. 48, Series 1998, established a program for Devolution Adjustment and Equalization Fund, renamed as Local Government Services Equalization Fund (LGSEF) which is primarily

aimed at enhancing the capacities of LGU's to fully and effectively exercise their devolved functions, services and facilities;

WHEREAS, the Municipal Government of Taytay desires to implement the project, entitled, construction of Four Storey Building for Taytay University of Rizal System Taytay, Rizal which is a local priority project congruent with the socio-economic and development agenda of the "Estrada Administration";


WHEREAS, the Municipal Government of Taytay lacks the financial capability to implement the aforementioned project;

NOW THEREFORE, be it resolved as it is hereby resolved by the Members of the Sangguniang Bayan to endorse the said project for funding support under the LGSEF;



APPROVED, this 12th day of November, 2001 at the Session Hall Municipal Building, Taytay, Rizal.


