


**ENACTING IN REVIEW RESOLUTION NO. 01 -S 2002 UNDER
APPROPRIATION ORDINANCE NO. 2 -2002 ANNUAL BUDGET
OF BARANGAY SAN ISIDRO TAYTAY, RIZAL**

WHEREAS, request for approval in review of Annual Budget of Barangay San Isidro for fiscal year 2002 was submitted for consideration of the August Body;

WHEREAS, the Municipal Budget Officer recommends for the approval of the same having found to have complied with the budgetary requirements as provided for by R.A. 7160;

RESOLVED, as it is hereby resolved, the Sangguniang Bayan of Taytay, Rizal duly assembled in session hereby approves Annual Budget of Barangay San Isidro FY 2002 in the amount of Six Million Eight Hundred Thousand Pesos (Php 6,800,000.00) under Appropriation Ordinance No. 02 series of 2002 of Barangay San Isidro Taytay, Rizal;

SECTION 1. That the said budget is subject to the terms, conditions and limitations imposed by the Municipal Budget Officer David Z. 



Atanacio, Jr. in their report dated March 4, 2002 pursuant to the provision of the implementing Rules and Regulations of R.A. 7160 otherwise known as the Local Government Code of 1991;

SECTION 2. The required revision/adjustment should be made, copies of the action taken shall be furnished the Municipal Budget Office;

SECTION 3. Disbursement of the herein approved appropriation should be in accordance with COA Rules and Regulations;


SECTION 4. Disbursement should be within the cash limit of the Barangay;

SECTION 5. That expenditure therein should be within the purpose for which they have been appropriated;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
