WHEREAS, to ensure the safety of our constituents and their properties from devastation due to flood, preventive and safety measures must be done;


WHEREAS, the Municipal Government of Taytay cannot support the project because of inadequate equipment and fund;


RESOLVED, FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
