illumination fund to installation of street lights at E. Rodriguez Avenue, Barangay San Isidro, Taytay, Rizal;


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.

ADOPTED, this 10th day of March, 2003 at the Session Hall of the Municipal Building, Taytay, Rizal.


