
**A RESOLUTION EARNESTLY REQUESTING HONORABLE

TAYTAY, RIZAL**


WHEREAS, Philippine National Police (PNP) Headquarters, Taytay, Rizal has deteriorated through the years since it was first built;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
