WHEREAS, in order to cope with the flooding and damages brought about by said typhoon it becomes necessary that the Municipality be declared under the state of calamity'




RESOLVED FURTHER, that copies of this Resolution be furnished to all authorities concern for their information and appropriate action.

ADOPTED, this 28th day of May 2003, at the Session Hall Municipal Building of Taytay, Rizal.


