WHEREAS, the Municipal Government of Taytay and the Local School Board will give priority in appropriating funds for the improvement of Taytay National High- School Annex;


NOW THEREFORE, on motion duly seconded, it was,


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.

ADOPTED, this 2nd day of June, 2003 at the Session Hall of the Municipal Building, Taytay, Rizal.


