**REQUESTING ALL HEAVY LOADED TRUCKS
10 WHEELERS AND ABOVE PASSING ALONG
TAPAYAN BRIDGE AND SAN LORENZO RUIZ
ROAD TO MAINTAIN LOAD LIMITS OF 20 TONS
AS PRESCRIBED BY DEPARTMENT OF PUBLIC
WORKS AND HIGHWAYS**

WHEREAS, the primary objective of the Local Government is to ensure safety and maintain road courtesy at the vicinity of Taytay, Province of Rizal;

WHEREAS, it has been observed that the implementation in weight limits for all heavy loaded trucks (10 wheelers and above) passing along Tapayan Bridge is not strictly implemented;

WHEREAS, the said findings will endanger the the condition of the said bridge to served the commuters and vehicles passing by;


WHEREAS, the Barangay Tanod in the area can be tapped to monitor on this purpose;

NOW THEREFORE RESOLVED, as it is hereby resolved by the Sangguniang Bayan in session to requests all heavy loaded trucks (10 wheelers and above) passing along Tapayan Bridge and San Lorenzo Ruiz to maintain load limits of 20 tons as prescribed by the Department of Public Works and Highways;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.

ADOPTED, this 1st day of March, 2004 at the Session Hall Municipal Building, Taytay, Rizal.




