WHEREAS, SITIO SIMONA HOMEOWNERS ASSN. INC. has satisfied all requirements need for the approval of the alteration of plan;


WHEREAS, any materials falsehood in part or inwhole will be subject for revocation or cancellation of said alteration;


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.
