WHEREAS, the tenant/tiller of the said lot has requested the Municipal Government of Taytay for a just compensation;


WHEREAS, upon payment the tenant/tiller shall vacate the said lot to give way for the full implementation of the project;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
