RESOLUTION NO. 83

**GRANTING AUTHORITY TO THE MUNICIPAL MAYOR
HON. GEORGE RICARDO R. GACULA II, TO REPRESENT
THE GOVERNMENT IN NEGOTIATING FOR AND ENTERING
INTO A MEMORANDUM OF AGREEMENT WITH NATIONAL
FOOD AUTHORITY REPRESENTED BY MYRNA R. DOMINGO,
PROVINCIAL MANAGER, EAST DISTRICT OFFICE**

WHEREAS, National Food Authority is the government agency charged with, among others, ensuring the nation with adequate supply and distribution of grains;

WHEREAS, under the Local Government Code, Local Government Units have the authority to discharge the functions and responsibilities of national agencies and offices devolved to them;

WHEREAS, the Local Government Units are authorized to set aside five percent (5%) and twenty percent (20%) of their estimated revenue from regular sources as an annual lump sum appropriation for Calamity Fund and Special Development Fund, respectively;

WHEREAS, the Local Government Units have been tasked with providing basic social services at all times particularly in times of calamities;

WHEREAS, to provide basic social services to the populace, the Local Government Unit has requested National Food Authority to allow them to purchase rice on credit for the following purposes: (1) for relief operations whenever a state of calamity is declared in the locality, (2) for stockpiling in preparation of eventualities/emergencies that may occur at any given time and (3) for its rehabilitation project/program, to restore, rehabilitate, reconstruct the damage caused by the disaster to affected families and infrastructures;


WHEREAS, the National Food Authority cognizant of the needs of the people in times of emergency/calamity, has acceded to the request of the Local Government Unit for a rice loan;

NOW THEREFORE BE IT, as it is hereby resolved the Sangguniang Bayan of Taytay, Rizal duly assembled in session hereby grants authority to the Municipal Mayor Hon. George Ricardo R. Gacula II, to represent the government in negotiating for and entering into a Memorandum of Agreement with National Food Authority represented by Myrna R. Domingo, Provincial Manager, East District Office;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.

ADOPTED, this 30th day of August 2004 at the Session Hall, Municipal Building Taytay, Rizal.


