NOW THEREFORE RESOLVED, as it is hereby resolved the Sangguniang Bayan of Taytay in session hereby adopts a resolution urging




RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.

ADOPTED this 13th day of September 2004, at the Session Hall of the Municipal Building, Taytay, Rizal.


