WHEREAS, the primary objective of the Municipal Government is to provide the basic services to our people;

WHEREAS, the construction of Concrete Lined Canal at Hi-Way 2000 (Phase II) Barangay San Isidro, Barangay Sta. Ana and Barangay San Juan will ease the flow of floodwaters;


WHEREAS, the construction of concrete Line Canal will serve as diversion of floodwaters from Taytay River through Manggahan Floodway;

Pia Cayetano, Senator of the Republic of the Philippines to allocate funds for the construction of concrete Lined Canal at Hi-Way 2000 (Phase II) Barangay San Isidro, Sta. Ana and San Juan in the Municipality of Taytay, Province of Rizal;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concern for their information and appropriate action.

ADOPTED, this 4th day of October, 2004 at the Session Hall of the Municipal Building, Taytay, Rizal.


