new streetlights at Capricorn and Aquarius Street, Monpert Hills Subdivision Taytay, Rizal which are as follows:


1. G13-541 - Capricorn St. Monpert Hills Subdivision, Brgy. San Isidro


RESOLVED FURTHER, those copies of this Resolution are furnished to all concerned for their information and appropriate action.

ADOPTED, this 4th day of October, 2004 at Session Hall of the Municipal Building of Taytay, Rizal.


