**A RESOLUTION FOR THE ESTABLISHMENT OF A TRAINING
CENTER FOR CAPABILITY BUILDING TO BE FUNDED BY
NATIONAL AGRICULTURE AND FISHERY COUNCIL -
DEPARTMENT OF AGRICULTURE AND ITS LOCAL EQUITY**

WHEREAS, the LGU of Taytay, Rizal is requesting the National Agriculture and Fishery Council (NAFC) for financial assistance for the construction of a Training Center;

WHEREAS, the National Agriculture and Fishery Council (NAFC) under LEAD Program Phase II (Livelihood Enhancement for Agriculture Development) of Department of Agriculture (DAR) has provided a grant under Capability-Building (Establishment of Training Center);

WHEREAS, the total costs amounting to P509,662.00 of which P400,000.00 will be granted by NAFC and P109,662.00 will be equity or counter part fund of the LGU-Taytay. Pursuant to Resolution No. 108 and

through the LGU – Office of Agricultural Services has taken the initiative by proposing for the establishment of a training center;

WHEREAS, the area to be used is located beside the Office of the Agricultural Services and certified and cleared by Mr. Roberto S. Bernardino, OIC- Assessor's Office of the Taytay, Rizal-LGU;


WHEREAS, the objective of this project is to serve as a venue for capability-building and transfer of technology from research institutions;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concern for their information and appropriate action.

ADOPTED, this 4th day of October, 2004 at the Session Hall of the Municipal Building, Taytay, Rizal.


