**EXPRESSING INTENTION TO PARTICIPATE IN
THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS
(DPWH) – LOCAL GOVERNMENT UNIT (LGU) COST
SHARING PROJECT/PROGRAM INTENDED FOR THE
CONSTRUCTION OF UNPAVED, MUNICIPAL ROADS AS
ITS PRIORITY, COMMITTING THE AVAILABILITY OF
P500,000.00 AS COUNTERPART AND AUTHORIZING
THE HONORABLE MAYOR GEORGE RICARDO R.
GACULA II, TO ENTER INTO MEMORANDUM OF
AGREEMENT WITH DEPARTMENT OF PUBLIC WORKS
AND HIGHWAYS (DPWH) FOR THIS PURPOSE**

WHEREAS, with the initiative of the League of Municipality of the Philippines (LMP), Local Government Unit-Taytay signifies its intention to construct the unpaved municipal pavements of Taytay via this Department of Public Works and Highways – Local Government Unit Cost Sharing Program, being its priority project eligible for this program;

WHEREAS, this program is an opportunity for the Local Government Unit of Taytay to realize the concreting of the unpaved municipal roads timely that it cannot shoulder the project alone;




FINALLY RESOLVED, to furnish copies hereof all concerned for their information, reference and appropriate actions.

ADOPTED, this 18th day of October, 2004 at the Session Hall Municipal Building, Taytay, Rizal.


