WHEREAS, the Bill of Rights of the 1987 Philippine Constitution affirms the recognition of the State as enunciated in Section 8 Article III that xxx the right of the people including those as employed in the public and private sectors to form unions, association or societies for purpose not contrary to law shall not be abridged xxx;

WHEREAS, pursuant to Executive Order No. 180 issued by former President Corazon C. Aquino entitled "An Executive Order Providing Guidelines for the Right to Organize Government Employees, Creating a

11 Labor Management Council and for other purposes that supports the formation of union;


WHEREAS, the said Union may be formed particularly by all government employees and/or assist employees organization of their own choice for further protection of their interest likewise the interest to collectively pursue worthwhile activities as well as to discipline their ranks;

NOW THEREFORE BE IT RESOLVED, as it is hereby resolved the Sangguniang Bayan, Taytay, Rizal duly assembled in session hereby Advocates and Encourages All Municipal Employees to Form their Union for a Harmonious Relation Among Themselves in the Municipality of Taytay, Province of Rizal;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action;
