ISIDRO ST. EXTENSION BRGY. MUZON TO BE
UTILIZED FOR THE PUBLIC RIGHT OF WAY**

WHEREAS, Mr. Tranquilino Angeles is the rightful owner of a lot located at San Isidro St. Extension Barangay Muzon, Taytay, Rizal with an area of 482 Square Meters and covered by Tax Dec. No. 05-2433, Transfer Certificate Title Nos. 546793 and 604290;

WHEREAS, the owner has signified his willingness to sell his property to the Municipal Government of Taytay for the welfare and benefit of the community;

WHEREAS, the lot area has long been used by the nearby residents;


WHEREAS, Mr. Tranquilino Angeles maintains and develops the said property that benefit our constituents living on the nearby road lot;

NOW THEREFORE RESOLVED, as it is hereby resolved, the Sangguniang Bayan in session duly assembled hereby authorizes the Municipal Mayor Hon. George Ricardo R. Gacula II to negotiate and enter into a memorandum of agreement (MOA) with Mr. Tranquilino Angeles for the purchase of his property located at San Isidro St., Extension Brgy. Muzon to be utilized for public right of way;


RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriated action.

ADOPTED, this 6th day of December 2004 at the Session Hall, Municipal Building, Taytay, Rizal.


