agricultural products produced by our beloved hardworking workforce;


WHEREAS, the Municipal Government of Taytay lacks the financial capability to implement such project thus the need to seek financial assistance is inevitable;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concern for their information and appropriate action.

ADOPTED, this 23rd day of December, 2004 at the Session Hall of the Municipal Building, Taytay, Rizal.


