WHEREAS, since the declaration of International Women's Day, recognition has been given to women who have excelled in various


professions where they have shown remarkable performance, achievements and leadership;



ADOPTED, this 7th day of March, 2005 at the Session Hall Municipal Building Taytay, Rizal.


