WHEREAS, based on the recommendations of the Municipal Budget Officer, Mr. David Z. Atanacio, Jr. under Communication No. 0504-124 and


was endorsed to the Committee last April 18, 2005, finding same in accordance with the budgetary requirements and accounting rules and regulations, Be it;


RESOLVED FURTHER, that copy of this Resolution be furnished to all concerned for their information and appropriate action.

ADOPTED, this 25th day of April 2005 at the Session Hall of the Municipal Building, Taytay, Rizal.


