**RESOLUTION NO. 74**

**REQUESTING THE PHILIPPINE CHARITY  
SWEEPSTAKES OFFICE (PCSO) TO DONATE  
FOUR (4) AMBULANCES FOR FIRE/POLICE  
STATION, MSWD OFFICE, BARANGAY  
DOLORES AND BARANGAY STA. ANA,  
MUNICIPALITY OF TAYTAY, PROVINCE  
OF RIZAL**

WHEREAS, Section 16 of the Local Government Code of 1991 states  
that:

"Every local government unit exercise powers expressly granted, those necessity implied therefrom, as well as powers necessary, appropriate of incidental for it's efficient and effective governance and those which are essential to the promotion of the general welfare within their respective territorial jurisdiction local government units shall ensure and support among other things....promote health and safety..... of their inhabitants."

WHEREAS, Section 17 (b) (2) (iii) of Local Government Code of 1991 states that the local government until shall provide for the basic services and facilities which includes, but not limited to the following and shall:

**“xxx (iii) subject to the provisions of this Code, health services which include the implementation of programs and projects on primary health care.....xxx.....access to secondary and tertiary health services, purchase of medicines, medical supplies and equipment needed to carry out the services herein enumerated.”**

WHEREAS, Section 11 of Articles XIII of the Philippine Constitution states that:

**“xxx shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all people to applicable costs, there shall be priority for the needs, as the under privileged, sick, elderly, disabled women and children. The state shall endeavor to provide free medical care to paupers xxx.”**

**“xxx (xvii)....formulate policies and adopt measures mutually beneficial to the elderly and to the community”.....xxx appropriate funds to support programs and projects for the benefit of the elderly xxx.”**

WHEREAS, increasing needs of the province growing population manifest the necessity of providing four (4) ambulances most particularly to serve the senior citizens and various indigent family located in rural areas of Taytay, Rizal;

WHEREAS, no less than 10,000 senior citizens, aged above sixty (60) resides in depressed area and their medical and health problems could not be address by the municipal government due to financial constraints;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Taytay, Rizal in session duly assembled hereby requests the Philippine Charity Sweepstakes Office (PCSO) to donate four (4) ambulances for fire/police station, MSWD Office and Barangay Dolores and Barangay Sta. Ana, Municipality of Taytay, Province of Rizal;

RESOLVED FURTHER, that copies of this Resolution be furnished to the Philippine Charity Sweepstakes Office (PCSO), Office of the Mayor, Municipal Health Office and Municipal Treasurer's Office, for their information and appropriate aciton.

ADOPTED, this 16<sup>th</sup> day of May 2005 at the Session Hall of the Municipal Building, Taytay, Rizal.








