WHEREAS, most of the members of the Dupax Homeowners Association belong to the low-income group;


WHEREAS, the Municipal Government lacks financial capability at present;


RESOLVED FURTHER, that copies of this resolution be furnished to all concern for their information and appropriate action.

ADOPTED, this 20th day of June 2005 at the Session Hall of the Municipal Building of Taytay , Rizal.


