**RESOLUTION NO. 99**

**AUTHORIZING MUNICIPAL MAYOR HON. GEORGE  
RICARDO R. GACULA, II TO NEGOTIATE AND ENTER  
INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE  
PHILIPPINE HEALTH INSURANCE CORPORATION AND  
GLAXOSMITHKLINE PHILIPPINES INCORPORATED**

WHEREAS, the PHILIPPINE HEALTH INSURANCE CORPORATION, a government owned and controlled corporation, organized and existing by virtue of Republic Act 7875 otherwise known as the National Health Insurance Act of 1995, with principal office at the CityState Center Building, 709 Barrio Oranbo, Shaw Boulevard, Pasig City and duly represented by its Vice President of National Capital Region group, Rodolfo M. Balog;

WHEREAS, the GLAXOSMITHKLINE PHILIPPINES INCORPORATED, a private pharmaceutical corporation with principal office at 2266 Don Chino Rocess Avenue, Makati City and duly represented by its President and Managing Director Amado T. Tadena;

WHEREAS, the Municipality of Taytay a Local Government Unit duly organized and existing under and by virtue of the laws of the Republic of the

Philippines with office address at Taytay, Rizal herein represented by Municipal Mayor Hon. George Ricardo R. Gacula II;

WHEREAS, the Indigent Program component of NHIP (National Health Insurance Program) otherwise known as Philhealth sponsored program provides a mechanism to identify qualified indigent families and to grant them membership to NHIP through full or partial government subsidies;

WHEREAS, the Indigent Program envision to set into motion an efficient health care financing and delivery program for the marginalized or indigent sector of our society anchored on Local Government Autonomy;


WHEREAS, as a response to the Filipino's need for access to qualified health care, GlaxoSmithKline Philippines Inc., as Corporate Sponsor has expressed in intent to donate to the Local Government Unit an amount to be used exclusively for the payment by the LGU of its premium counterpart for 500 indigent households from the Municipality of Taytay (the "Beneficiaries") under the terms and conditions stipulated herein;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan duly assembled in session, hereby authorizes Municipal Mayor Hon. George Ricardo R. Gacula II to negotiate and enter into a Memorandum of Agreement (MOA) with the Philippine Health Insurance Corporation and Glaxosmithkline Philippines;


RESOLVED FURTHER, that copies of this resolution be furnished to all concern for their information and appropriate action.

ADOPTED, this 20<sup>th</sup> day of June 2005 at the Session Hall of the Municipal Building of Taytay , Rizal.


