**RESOLUTION NO. 117**

**REQUESTING THE PRESIDENTIAL AGRARIAN REFORM  
COMMITTEE AND COMPREHENSIVE AGRARIAN  
REFORM PROGRAM OFFICE TO REALIGN THE  
AMOUNT OF THREE MILLION PESOS (P3, 000,000.00)  
FOR THE CONSTRUCTION/IMPROVEMENT OF  
BARANGAY SAN ISIDRO FARM TO MARKET ROAD  
TO THE PROPOSED FARM TO MARKET ROAD ALONG  
TAYTAY RIVER OF BARANGAY SAN JUAN AND STA ANA,  
TAYTAY, RIZAL**

WHEREAS, there is a Comprehensive Agrarian Reform Program (CARP) funded project entitled Improvement of Barangay San Isidro Farm to Market Road at the Department of Land Reform which was validated and inspected by the Municipal Land Reform Office;

WHEREAS, as per report of the said office they found out that the said area has no Agrarian Reform Beneficiaries and they recommend for the realignment of the said project to other areas;

WHEREAS, the Sanggunian Bayan had previously adopted a resolution re-aligning the said project to the Proposed Kalayaan Avenue but upon validation of Provincial Land Reform Office they found to be not in conformity due to lack of requirements for a Farm to Market Road;

WHEREAS, the other project approved by the Comprehensive Agrarian Reform Program is for the proposed initial Farm to Market Road along Taytay River at Barangay San Juan and Sta. Ana, Taytay, Rizal;


WHEREAS, the Sangguniang Bayan deems it proper to request for re-alignment of Improvement of Barangay San Isidro Farm to Market Road project to the proposed Farm to Market Road along Taytay River at Barangay San Juan and Sta. Ana, Taytay, Rizal for its continuity;

NOW THEREFORE BE IT RESOLVED, as it is hereby resolved, to requests the Presidential Agrarian Reform Committee and Comprehensive Agrarian Reform Program Office to re-align the amount of Three Million Pesos (P3,000,000.00) for the construction/improvement of Barangay San Isidro Farm to Market Road to the proposed Farm to Market Road along Taytay River of Barangay San Juan and Sta Ana, Taytay, Rizal;

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.




