
WHEREAS, turn over of road right of way to the local government will be an assurance of its development and maintenance for the benefit of their community;

WHEREAS, there is a need to authorize the Municipal Mayor to enter and accept the donation of the road right of way;



ADOPTED, this 8th day of August, 2005 at the Session Hall of the Municipal Building, Taytay, Rizal.


