**DECLARING THE POSITION OF OFFICE OF THE SENIOR
CITIZENS AFFAIRS (OSCA) HEAD AS VACANT DUE TO THE
UNTIMELY DEATH OF MR. MARIANO DE LEON AND
RECOMMENDING TO THE LOCAL CHIEF EXECUTIVE
HONORABLE GEORGE RICARDO R. GACULA II THE
NOMINEES TO FILL-UP THE POSITION OF HEAD OF THE
OFFICE SENIOR CITIZENS AFFAIRS (OSCA)**

WHEREAS, continuity of public service is of utmost importance to every Local Government Unit in consonance with its accountability to the people;

WHEREAS, due to the death of Mr. Mariano De Leon last March 19, 2006, Head of the Office of the Senior Citizens Affairs (OSCA), there is a vacancy on the said position;

WHEREAS, in order to prevent any hiatus in rendering effective service to the people more particularly to the senior citizens, the Sangguniang Bayan deems it necessary to fill-up the vacancy thru appointment for the remaining term;

WHEREAS, the Section 25 of IRR of R.A. 9257, otherwise known as the Senior Citizens Law provides that, "the OSCA head shall have a term of office of three (3) years without reappointment. In case of death or permanent disability, the remaining term shall be served by the new appointee.....;"

WHEREAS, public service should continue by means of appointing a new OSCA Head from the list of nominees submitted to the Sangguniang Bayan.

WHEREAS, the nominees vying for the position of OSCA HEAD are the following,
