RESOLUTION NO.78

DECLARING THE ENTIRE MUNICIPALITY OF TAYTAY UNDER STATE OF CALAMITY DUE TO TYPHOON MILENYO

WHEREAS, on September 28, 2006 the Weather Bureau (PAG-ASA) and the National Disaster Coordinating Council had confirmed that Typhoon Milenyo will hit Southern Tagalog Region, specifically Metro Manila;

WHEREAS, due to the proximity of our Municipality to the said places the same advice and precautionary measures have been undertaken;

WHEREAS, after the occurrence of the said Typhoon it was noted that tremendous damages to property particularly on houses at the low-lying area had been affected by heavy rain and flashflood. The gusty wind had even uprooted trees, damaged electrical post and residence of constituents;

WHEREAS, to prevent the spread of diseases due to this calamity, the Municipality shall adopt contingency measures concerning the health of our constituents;

WHEREAS, in order to cope with the flooding and damages brought about by said typhoon it becomes necessary that the Municipality of Taytay be declared under the STATE OF CALAMITY;

NOW THEREFORE RESOLVED, as it is hereby resolved, the Sangguniang Bayan of Taytay duly assembled in session hereby declares the entire Municipality of Taytay under STATE OF CALAMITY brought about by Typhoon Milenyo;

RESOLVED FURTHER, that the Local Calamity Fund shall be utilized for relief, rehabilitation, reconstruction and other works and services, to be undertaken by the administration in connection with the calamities such expenditures shall be governed by the guidelines and procedures prescribed under the rules and regulation implementing Republic Act No. 8185, Amending Section 324 (d) Republic Act 7160, together w/ the joint Memorandum Circular No. 2003-1, 2003-2 of Department of Budget and Management & Department of Interior Local Government dated March 20, 2003 and dated July 24, 2003 respectively;

RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all authorities concern for their information and appropriate action;


