WHEREAS, there are viable funds from the CY 2006 excess Internal Revenue Allotment (IRA) and prior years adjustments of Accounts Payables amounting to Two Million Five Hundred Forty Four Thousand Nine Hundred Two & 79/100 Pesos (P2,544,902.79) which can be allotted to various project for the welfare of the Municipality;




