WHEREAS, the Municipal Government of Taytay applied for a MERALCO Service connection for the extension of secondary electrical facilities at Monpert Hills, Brgy San Isidro, Taytay, Rizal.

WHEREAS, the project cost is estimated at P 15,000.00 and that the final cost will be known when the design has been finalized;

WHEREAS, it is imperative to put up such electrification on the said areas to avoid accidents and unnecessary incidents;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved the Sangguniang Bayan of Taytay, Rizal duly assembled in session, hereby authorizes to charge the amount of Fifteen Thousand Pesos (P15,000.00) for extension of Secondary Electrical Facilities at Monpert Hills, Brgy. San Isidro, Taytay, Rizal;


RESOLVED FURTHER, that copy of this Resolution be furnished all concerned for their information and appropriate action;

ADOPTED, this 5th day of March 2007, at the Session Hall of the Municipal Building, Taytay, Rizal.


