AMENDING RESOLUTION NO. 16, SERIES OF 2007

WHEREAS, the Committee had to consider Section 19- Limitation of the Internal Rules and Procedure of the Sangguniang Bayan of Taytay;

SECTION 19 – Limitations – No Sanggunian Members shall be a chairman of more than three standing committees.

a). *No person other than members of the Sangguniang Bayan shall be made of any regular committee.*

b). *No members shall participate in the committee's deliberations if he has a direct personal or pecuniary interest on the matter being handled by that committee.*

c). *No member shall hold more than 3 Vice Chairmanship of a Standing Committee.*
