WHEREAS, the streets of Exodus Floodway A, from Block 1-32 is under the territorial jurisdiction and cadastral plan of Brgy. Sta. Ana, Taytay, Rizal;

WHEREAS, the Municipality of Cainta, illegally installed the street signs at the said area of Exodus, Barangay Sta. Ana and Rizal Avenue of Barangay San Isidro;

WHEREAS, the said issue has an existing complaint/pending decision at the Sangguniang Panlalawigan, hence a “status quo” ruling in the area;

WHEREAS, there is an urgent need to refer the matter to concern Committee of the Sanggunian Panlalawigan who will take care and resolve the issue;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, the Sangguniang Bayan of Taytay Rizal, duly assembled in session, hereby expresses their protest to the act of the Municipality of Cainta on the installation of street signs located under the jurisdiction of Taytay Rizal.

ADOPTED, this 18th day of October 2007 at the Session Hall, Municipal Building, Taytay, Rizal.


