RESOLUTION NO 1

GRANTING EXTENSION FOR THE PAYMENT OF REGISTRATION OR RENEWAL OF BUSINESS PERMIT AND LICENSES UP TO FEBRUARY 1, 2008 WITHOUT PENALTIES AND SURCHARGES

WHEREAS, payment of business permit and licenses has been stalled due to the requirements being imposed of the Professional Tax Receipt that no business permit and licenses shall be issued without registration from the Department of Trade and Industry;

WHEREAS, due to the economic crisis besetting our country and the financial difficulties felt by most businesses; taxpayers need more time to

pay their business permit and licenses to avoid necessary charges and penalties;

WHEREAS, it would be best to extend the payment of registration and renewal of business permit and licenses up to February 1, 2008 and to allow also the extension of working hours from 5:00 p.m. to 8:00 p.m. on the said day; relative to this to provide appropriate overtime pay for the personnel involved;


WHEREAS, the Sanggunian Bayan had required all concern departments and sections in the filling of business permit to provide a system of procedure in the implementation of the processing of payment for the convenience of the paying public;

NOW THEREFORE BE IT RESOLVED, as it is hereby resolved, the Sanggunian Bayan in session hereby extends the payment of Registration or Renewal of Business Permit and Licenses up to February 1, 2008 without penalties and surcharges;


RESOLVED FURTHER, to send copies of this Resolution to all person concern for their information and appropriate action.

ADOPTED, this 28th day of January, 2008 at the Session Hall of the Municipal Building, Taytay, Rizal.


