RATIFYING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 08-001 APPROPRIATING THE AMOUNT OF TWENTY SEVEN MILLION TWO HUNDRED NINETY TWO THOUSAND ONE HUNDRED EIGHTEEN & 20/100 PESOS (P 27,292,118.20) REPRESENTING THE CY 2008 20% DEVELOPMENT FUND TO VARIOUS PRIORITY PROGRAMS/PROJECTS FOR THE MUNICIPALITY

WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides in part that every local government unit shall exercise powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;


WHEREAS, the urgent needs in different areas municipality and other areas requires immediate action for the benefits of its constituents;

WHEREAS, the Municipal Development Fund will finance various priority projects for the Municipality;


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
