RESOLUTION NO. 20

**AUTHORIZING THE MAYOR HONORABLE GEORGE RICARDO
R. GACULA II TO NEGOTIATE AND TO ENTER INTO A
MEMORANDUM OF AGREEMENT BY AND BETWEEN THE
MUNICIPAL GOVERNMENT OF TAYTAY AND MANILA WATER
COMPANY INCORPORATED (MWCI) AT THE UNIVERSITY OF
RIZAL SYSTEM-TAYTAY CAMPUS**

WHEREAS, under the Charter (Republic Act No. 6234, as amended), the Metropolitan Waterworks and Sewerage System ("MWSS") now MWCI has jurisdiction, supervision and control over all waterworks and sewerage systems within the franchise area;

WHEREAS, MWCI is the concessionaire and agent of the MWSS for water and wastewater services in the Service Area East (which includes the

Municipality of Taytay) of the franchise area of MWSS including the management, operation, repair, decomposing and refurbishment of all the fixed and movable assets and facilities of MWSS in the said franchise area, under and by virtue of the Concession Agreement dated February 21, 1997 executed by and between MWCI and the MWSS (the "Concession Agreement");

WHEREAS, on December 15, 2005, the Municipal Council of Taytay and the Honorable Mayor George Ricardo R. Gacula II passed and approved respectively their Sangguniang Bayan Resolution No. 165 endorsing to the National Economic and Development Authority-Investment Coordinating Committee the approval of the MTSP intended for the improvement of sewerage and sanitation conditions in the east zone of Metro Manila;

WHEREAS, in line with the program initiated by MWCI, the Sanggunian Bayan of Taytay had to authorize the Municipal Mayor as mandated in Sec. 22 (c) of the Local Government Code of 1991;

WHEREAS, the Sangguniang Bayan Members shall ratify first the Memorandum of Agreement before its full implementation;

NOW THEREFORE, for and in consideration of the foregoing premises the Sangguniang Bayan of Taytay hereby authorizes the Municipal Mayor Hon. George Ricardo R. Gacula II to enter into MOA or negotiation with the Manila Water Corporation Incorporated:


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
