RESOLUTION NO. 25

**GIVING HAZARD PAY FOR HEALTH WORKERS IN TAYTAY
EMERGENCY HOSPITAL AS MANDATED BY THE
GOVERNMENT THROUGH THE MAGNA CARTA FOR HEALTH
WORKERS**

WHEREAS, based on Magna Carta for Health Workers (RA 7305) Public Health Workers are to be granted hazard pay based on Entitlement and Determination of personnel exposed to Hazards 7.1.4;

WHEREAS, the hazard pay is exclusive only for Public Health Workers and personnel in High Risk Hazardous Area which includes the following: works areas in the hospital, sanitaria, rural health units, health centers, clinics, barangay health stations, municipal health offices, and infirmaries. Hence, in this category all field health workers giving direct

service delivery are already classified as high risk and therefore Health Workers of Taytay, Rizal;

WHEREAS, all employees who would be availing the hazard pay privilege would have a written application submitted to DOH as per approval of the said privilege;

WHEREAS, personnel who are not itemized under Taytay Municipal Health Office are not entitled to receive the hazard pay since they are not classified to be working in High Risk Hazardous areas;

WHEREAS, all employees shall be receiving the hazard pay in pursuant of the Revised Implementing Rules and Regulations of the Magna Carta of Public Health Workers without the need of approval from Department of Budget and Management (DBM);


WHEREAS, it was agreed upon that recipient of the hazard pay is exclusive only for regular employees and new employees who had rendered one (1) year of continuous service;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved that hazard pay shall be given for health workers in Taytay Emergency Hospital as mandated by the government through the Magna Carta for health workers.


RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and guidance.
