**RESOLUTION NO. 41**

**EARNESTLY REQUESTING HONORABLE PILAR JULIANA S.  
CAYETANO, CHAIRPERSON OF COMMITTEE ON HEALTH &  
DEMOGRAPHY, SENATE OF THE PHILIPPINES, TO DONATE  
THREE (3) AMBULANCES FOR THE MUNICIPALITY OF  
TAYTAY, PROVINCE OF RIZAL**

WHEREAS, Section 16 of the Local Government Code of 1991 states that:

*“Every Local Government Unit exercise powers expressly granted, those necessity implied therefrom, as well as powers necessary, appropriate of incidental for it's efficient and effective governance and those which are*

*essential to the promotion of the general welfare within their respective territorial jurisdiction local government units shall ensure and support among other things...promote health and safety...of their inhabitants."*

WHEREAS, Section 17 (b) (2) (iii) of Local Government Code 1991 states that the Local Government Unit shall provide for the basic services and facilities which includes, but not limited to the following and shall:

*"xxx (iii) subject to the provisions of this Code, Health Services which include the implementation of programs and projects on primary health care ...xxx...access to secondary and tertiary health services, purchase of medicines, medical supplies and equipment needed to carry out the services herein enumerated."*

WHEREAS, Section 11 of Articles XIII of the Philippine Constitution states that:

*"xxx shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all people to applicable costs, there shall be priority for the needs, as the under privileged, sick, elderly, disabled women and children. The state shall endeavor to provide free medical care to paupers' xxx"*

WHEREAS, increasing needs of the province growing population manifest the necessity of providing three (3) ambulances most particularly to serve the Senior Citizens and various indigent family located in Rural and Urban areas of Taytay, Rizal;

WHEREAS, no less than 15,000 senior citizens aged above sixty (60) years old reside in the depressed area and their medical and health problems could not be address by the Municipal Government due to lack of financial resources;

WHEREAS, the said ambulances be granted to Taytay Emergency Hospital, Liga ng mga Barangay Office and Brgy San Isidro, Taytay, Rizal;

NOW THEREFORE, BE IT RESOLVED as it is hereby resolved by the Sangguniang Bayan of Taytay, Rizal in session duly assembled hereby REQUESTS HON. PILAR JULIANA S. CAYETANO, CHAIRPERSON OF COMMITTEE ON HEALTH & DEMOGRAPHY, SENATE OF THE PHILIPPINES, TO DONATE THREE (3) AMBULANCES FOR THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that copies of this Resolution be furnished to Hon. Pilar Juliana S. Cayetano of the Senate of the Philippines, Municipal Heath Office, Office of the Mayor and Municipal Treasurer's Office, Municipal Social Welfare Office for their information and appropriate action.
