**RESOLUTION NO. 56**

**REQUESTING THE HONORABLE MEMBERS OF THE 25<sup>TH</sup>  
SANGGUNIANG PANLALAWIGAN OF RIZAL, AS WELL AS THE  
CONGRESSMEN AND CONGRESSWOMEN FROM THE  
PROVINCE OF RIZAL TO INITIATE THE FILLING OF AN  
APPROPRIATE SP RESOLUTIONS/HOUSEBILL IN CONGRESS  
REDISTRICTING THE PRESENT CONGRESSIONAL DISTRICTS  
IN THE PROVINCE OF RIZAL INTO SIX (6) SEPARATE  
LEGISLATIVE DISTRICTS**

WHEREAS, basic is the rule on republicanism that one man's votes should carry as much weight as the vote of every other man;

WHEREAS, statistics show that the Municipalities of San Mateo and Rodriguez occupy the largest voting population among the municipalities in the present 2<sup>nd</sup> District, Province of Rizal;

WHEREAS, time has come that the other municipalities in the Province of Rizal which are geographically contiguous, compact and adjacent territories be properly represented in the highest lawmaking body in the country;

WHEREAS, the redistricting of the thirteen municipalities and component city in the Province of Rizal will prove to be beneficial to all Rizaleños in terms of delivery of basic services and construction of needed infrastructure projects;

WHEREAS, the redistricting of the thirteen municipalities and component city in the Province of Rizal into six (6) separate legislative districts to be composed of the following to wit:

1<sup>st</sup> District, Province of Rizal, to be composed of the Municipalities of Cainta and Taytay;

2<sup>nd</sup> District, Province of Rizal, to be composed of the Municipalities of Angono, Binangonan and Cardona;

3<sup>rd</sup> District, Province of Rizal, to be composed of the Municipalities of Morong, Teresa, Baras, Tanay, Pililla and Jalajala;

4<sup>th</sup> District, Province of Rizal, to be composed of the Municipalities of San Mateo and Rodriguez;


5<sup>th</sup> District, Province of Rizal, to be composed of the barangays comprising the present 1<sup>st</sup> District, Antipolo and

6<sup>th</sup> District, Province of Rizal, to be composed of the barangays comprising the present 2<sup>nd</sup> District, Antipolo City.

Satisfies the basic constitutional requirement for the creation of legislative districts under Article VI. Sec. 5 (3) of the 1986 Constitution as the same geographically contiguous, compact and adjacent;

WHEREAS, as duly elected legislators of the Province of Rizal, it is incumbent among them that the legitimate concerns of their co-Rizaleños are properly addressed through appropriate legislation;

NOW THEREFORE, be it Resolved as it is hereby resolved by the Sangguniang Bayan of Taytay, Rizal requesting the Honorable Members of the 25<sup>th</sup> Sangguniang Panlalawigan of Rizal, as well as the Congressmen and Congresswomen from the Province of Rizal to initiate the filing of an appropriate SP Resolutions/House Bill in Congress redistricting the present Congressional Districts in the Province of Rizal into six (6) separate legislative districts.





RESOLVED FURTHER, that copies of this Resolution be furnished to all authorities concerned for their information and appropriate action.


