**AMENDING RESOLUTION NO. 23 SERIES OF 2007.**

**AUTHORIZING TO CHARGE THE AMOUNT OF TWELVE THOUSAND  
FIVE HUNDRED SEVENTEEN PESOS (P 12,517.00) FOR THE MONTH OF  
SEPTEMBER TO DECEMBER 2008 TO ILLUMINATION FUND FOR SEVEN
