SANTOS NATIONAL HIGH SCHOOL (TAYTAY NATIONAL HIGH SCHOOL) FOR THE ELECTRIFICATION PROGRAM OF BOTH SCHOOLS LOCATED AT RIZAL TECHNOPARK 2000, BRGY. SAN JUAN, TAYTAY, RIZAL, TO BE CHARGED UNDER THE ILLUMINATION FUND




RESOLVED FURTHER, that copies of this Resolution be furnish to all concerned for their information and appropriate action.
